### Government Committee of Inquiry - the work

- One man Inquiry
- Three different groups
  - Expert group with participants from different governmental departments and authorities directly concerned with the issues
  - A reference group with participants from the parties in the Swedish parliament
  - A reference group with participants from the market (both Swedish and foreign) and other stakeholders
- Meetings with other gambling authorities concerning best practice (UK, Denmark and Netherlands)
- Meetings with other concerned parties like finanical institutions, ISP:s and law enforcement authorities



## Government Committee of Inquiry the goal - channelling

- The most important thing according to the inquiry was channelling
- The goal? At least 90 percent within two years
- The "foreign" companies are already on the Swedish gambling market



## Government Committee of Inquiry - the proposal, highlights

- Land based casinos and VLT:s are still to be a monopoly for the state
- Land based and online lotteries (excl. bingo) are reserved for the state and non-profit associations which promote objects that are of public benefit
- Online gambling and betting (both land based and online) are opened for licencing



#### **Re-regulation of the Swedish gambling market**

The purpose of the re-regulation

- Regaining control of the Swedish gambling market and
- Customer protection.

- not primarily a liberalization of the market



#### Timetable

- Parliament decision June 2018 new Gambling Act
- Possibility to apply for a licence from August 2018
- A new Gambling Act in force January 2019
- Extremely tight time-frame both for SGA and the industry







#### A new Gambling Act in force

- A frame legislation for all gambling The objective of the legislation is set in the act.
  - Details in secondary legislation.
- One authority Spelinspektionen The government and the counties can no longer grant licences.



#### The new Gambling Act



- All operators on the Swedish gambling market are to have a licence.
- Operators without a necessary licence shall be excluded.
- The regulation
- is to promote gambling that is healthy and safe, and that has a high level of consumer protection.
- shall not increase gambling and the negative consequences of gambling should be limited.
- should as far as possible secure the conditions for financing central government activities and public interests.
- The marketing of gambling should be moderate.



#### Types of licenses in the new Gambling Act

- Online gambling
- Betting
- Gambling arranged by the state (VLT and Casino)
- Gambling arranged by Non-profit associations which promote objects that are of public benefit
- Land based commercial gambling
- Gambling on vessels in international traffic

#### New regulation – major challenges for SGA

- New legislation Gambling Act
- Increased responsibilities
- Increased number of licenses
- New operators on the market
- Self-exclusion register
- International co-operation
- Gambling responsibility measures
- Matchfixing council
- AML-regulation run in parallell
- GDPR/new administrative law in force

- Reorganization
- Increased number of employees >50 %
- Recruting adequate competence/expertise
- More office space
- Internal/external communication and information
- Strenghtened compliance and supervision
- Technical adjustments/IT-support
- Business intelligence/market research
- New name/new logotype





#### The application process 2018

- The goal at least 90 percent channeling within two years.
- The goal was never to grant a license to all applicants before January 2019.
- No "grace period" allowed.

Swedish authorities are governed by administrative laws – equality, impartiality, objectivity.

- 14 on-going courtproceedings
- 9 pending in the Administrative Court of Appeal
- About 80 completed court cases since 2019
  25 violations of the regulation
  24 regarding licensing
